- The integrated discussion is a chapter which is specific to a thesis which contains publications. It provides a 'big picture', in which all the individual papers become part of one cohesive research story, as an original contribution to knowledge
- The integrated discussion is what *makes* a whole thesis out of a bunch of papers.

What is an integrated discussion?

USyd: [A] research thesis is a coherent and cohesive narrative describing a body of scholarly activity that adds to knowledge. At the University [of Sydney] a collection of published papers is not a thesis, neither is a publication on its own sufficient to warrant the award of a research degree.

Monash: A Thesis Including Published Works [...] must reflect a sustained and cohesive theme related to a defined research project. Framing or substantial linking text is required in introducing the research and connecting the chapters/papers and/or manuscripts.

UQ: All theses that include publications must be formatted according to the requirements outlined in the Higher Degree by Research Examination Policy [including] [...] iii. An independent and original discussion that integrates the significant findings of the thesis.

Writing an integrated discussion is like juicing a pomegranate...



Writing an integrated discussion is like juicing a pomegranate...

- You have to both separate and combine smaller pieces
- O It needs some extra steps, and it takes time to get it right
- If you make it work, the outcome is very good for you (if you get it right, thesis examiners find it delicious!)

Why you need the good juice...

- Two prominent concerns of examiners in thesis by publication: 1. contribution in co-authored papers and 2. coherence of the thesis (Sharmini et al., 2015)
- Examiners often ask for revisions when there is not enough to show how the publications fit together as parts of one research story (Moodie & Hapgood, 2012)
- However, examiners are swayed in favour of the thesis, when the integration is done well:

I was particularly convinced by [...] the success with which these chapters tied the publication chapters together into a cohesive story (Moodie & Hapgood, 2012)



- Candidates writing a thesis by publication frequently name thesis cohesion as one of the challenges (Merga et al.,2020)

- Common issues
 - Difficult to find a 'whole story'
 - Later papers don't fit with earlier ones
 - Not sure how to avoid repetition
 - Not sure what chapter structure is possible

- Traditional Discussion chapter functions...
 - o Interprets your data analysis Moving beyond summary & analysis, towards making claims
 - Links claims directly to the research questions showing you have achieved your aims
 - o Shows how findings are similar or different to those in previous research, and why this might be
 - Notes limitations
- Traditional Conclusion chapter functions...
 - Remind the reader of the aims and questions of the thesis
 - o Remind us that the Discussion has shown how these aims and questions have been addressed
 - Emphasises contribution to knowledge
 - Propose implications for future research
 - o Propose implications for other contexts e.g. industry, policy, professional practice

Often these functions are combined into one chapter – BUT all the functions are still needed.

Functional parts of the integrated discussion

- Traditional Discussion chapter functions...
 - o Interprets your data analysis Moving beyond summary & analysis, towards making claims
 - Links claims directly to the research questions showing you have achieved your aims
 - O Shows how findings are similar or different to those in previous research, and why this could be
 - Notes limitations
- Integrated discussion chapter does all that but has differences, because...
 - your included publications already have their own discussions, their own claims
 - however the ID chapter cannot simply summarise these claims...
 - so you need to make claims about your claims, linked to a big picture that they fit into
 - (The big picture needs to be set up in your thesis Introduction chapter)

Some types of connections between publications...

- Papers may be related because they are co-types (e.g. study with clinicians, study with patients, study with carers)
- Papers may be related because they are co-parts (e.g. theoretical publication, methodological paper, empirical study)
- Papers may be related because they are sequential (e.g. scoping review, pilot study and evaluation, full design and evaluation)

One of the ways that the Integrated Discussion is the same as a traditional Discussion:

- The big picture must connect the whole thesis
- So the big picture needs to be set up in your Introduction chapter
- So you will need to write/re-write your
 Introduction after/while you write your
 Integrated Discussion (and Conclusion)
